

## Child Passenger Safety (CPS) Training?

Unintentional injuries are the leading cause of death and injury to our children under the age of 16. **The number one killer of our youth is motor vehicle crashes.** Effective child passenger safety training is very important – not only in terms of providing technical information, but also in raising the awareness of the importance of proper occupant restraint usage by our youngest and most precious travelers. Wyoming has a misuse rate of car seats from 86% - 93%.

The course will expand your existing skills and increase your confidence, enabling you to better provide this valuable, lifesaving service to your community. Documented CPS training and experience also can help reduce employer and practitioner liability.

Upon completion of the NHTSA (National Highway Traffic Safety Administration) standardized course, which has both written and hands-on components of testing, you will be certified as a Child Passenger Safety Technician.

## Who Should Attend?

Anyone involved in child passenger safety education that wishes to teach accurate information to parents or the general public. **Continuing education contact hours (CECH) are available for law enforcement.**
